'GP Commissioning and Design' is an event that brings together Service Designers and GPs to exchange views and practices related to the newly developed programme of GP Commissioning. The event will provide an overview of GP commissioning with examples of Design interventions and GP driven projects. We will build upon findings from our recently concluded research project focused on Practice Based Commissioning, which highlighted the need for a collaborative and creative framework defined as 'Community-centred Commissioning'. A practical exercise will explore elements of this framework, demonstrating use of tools and approaches from both disciplines.

What is GP Commissioning?

GP Commissioning is the recent evolution of Practice Based Commissioning (PBC). Under PBC Primary Care Trusts have held the final authority for service redesign and commissioning, along with budgetary control. Now GPs are being 'liberated' from these external mechanisms of control and have been presented with a huge opportunity to lead change at a local level. This implies though a loss of skill base that may leave a vacuum in the organisational structure of the NHS. Also GP consortia are expected to develop integrated care proposals, developing a 'compact', or formal agreement, with local authorities and the third sector. This involves investing considerable time in building trust and relationships through peer-to-peer dialogue and systemic thinking.

Why Design?

Design has been increasingly working with healthcare organisations to re-imagine service models and provisions, introducing an experience-based approach to innovation. This 'grass roots' or 'bottom up' approach has been proven to be more effective in promoting behaviour change in individuals, which, when combined with the systems approach of Evidence Based Design, offers an integrated approach which may provide the ideal environment to conceive of, and effectively implement, service redesign proposals in healthcare settings. Also designers have been developing tools and methods to support creative and collaborative change processes, engaging diverse groups of stakeholders.

The Design in Practice project aimed to investigate how GP practices were engaging with the Practice Based Commissioning (PBC) framework, how they applied their situated knowledge to the design of new healthcare service models and facilities, and what creative design skills could support them in envisioning and commissioning new services.
